WHAT IS TOYOTA GOING TO DO?

Owners of the involved vehicles will receive a campaign notification by first class mail.

- (1) For the fuel pipe:
The Toyota retailer / authorized repairer will **replace the fuel pipe with an improved one.** The replacement will be performed at **NO COST** to vehicle owners.
- (2) For the high pressure fuel pump:
The Toyota retailer / authorized repairer will **replace the check valve and gasket with an improved one.** The replacement will be performed at **NO COST** to vehicle owners.

Depending on the involved vehicles production date, the TOYOTA retailer / authorized repairer will perform operation (1) or combine operation (1) and (2).
